Actually back in the 1998, 1999 or early 2000 Paula set up a Perpetual Scholarship/Calendar savings account with Chapter Approval by transferring funds into a separate account. Those funds, interest over several years and funds turned back by returned checks or checks not cashed are where the bulk of the funds came from.
